- Legislative Update on hiatus until April 25 then veto session. In the appropriations bill to add 10 million to enhance Medicaid.
- Regional Homeland Security Project update John Hultgren / Missy McGinnis We need to
 gather an accounting of which device services currently have and which they prefer receiving.
 The RHS project will replace these devices on a rotating basis to replace them before they
 outdate.
